CPC: Brief Outlook on Internal Training

- Mid-February 2012 held management and examiner briefings
- CPC Training Pilot (beginning June 2012) USPTO
 - Bilateral training pilot to include:
 - ~ 100 pre-classification experts
 - ~ 150 future trainers
 - ~ 35 examiners
 - USPTO trainers will gain experience and can fine-tune training materials for internal and external users
 - Field-Specific Training (FST) on CPC Definitions

- USPTO and EPO are jointly developing a training concept and reference materials
 - Training will:
 - Allow for Computer Based Training (CBT) e-learning modules
